Legends Paintball Rules and Regulations

The following rules and regulations must be adhered to, while you are on the property, whether involved in a game of paintball or not. Any infraction will be sufficient grounds to terminate that person's use of the facilities and to consider them a trespasser on the property. There may be, from time to time, additional or special rules, or a deletion of some rules for a specified game or games. In any case, any deletions or additions will be posted and/or announced prior to the start of any game.

ILLEGAL MARKERS & DEVICES

- **A.** Any marker that shoots over 300 feet per second, on a three shot average.
- **B.** Markers that shoot more than one paintball at a time.
- **C.** Fully automatic paintball markers.
- **D.** Knives, hatchets, machetes, etc.
- E. Firearms of any kind.

ILLEGAL ACTIONS AND PERFORMANCE

- **A.** Alcohol or drugs prior to, during a game, or after your session has ended.
- **B.** Hand to hand combat or physical contact.
- **C.** Abusive language or actions.
- **D.** Moving or altering structures, barricades, foxholes, safety devices, markers, etc.
- **E.** Entering or remaining in a playing field or area without protective eyewear.
- **F.** Intentional shooting at the head.
- **G.** Shooting at a player within 10 feet.
- **H.** Climbing trees, entering restricted areas, or exiting the property.
- I. Discharge of any paintball marker in a safety zone.
- **J.** Shooting at animals, vehicles, buildings, spectators, or officials.
- **K.** Cutting trees, digging holes, constructing snares, traps, or any other such device.
- L. Shooting a player more than three times in a single action.
- **M**. Shooting a player that has called himself or herself out.

GENERAL RULES

A. A referee may call for a velocity check of any marker at any time. Any marker found to be shooting over 300 feet per second may be eliminated

from use by any referee. A second violation of a velocity check will cause that player to be eliminated from the session.

- **B.** If a "paint check" is called, play will continue until the Referee reaches the player in question. All players are "active" until the Referee calls the player in question "neutral." They can shoot and be shot at until they are called "neutral." The Referee will check the player for a hit, and will then call the player "in" or "out" based on their determination. There will be a 5 second countdown before play resumes if they are "in."
- **C.** In the event that a referee blows his whistle:
 - 1. The game will stop in that area.
 - 2. All players will maintain their position.
 - 3. Referee will announce: "paint check, rule infraction, velocity check, etc."
 - 4. The game will resume play based upon the referee's discretion.
- **D.** When you are hit:
 - 1. Call yourself "OUT" or "HIT." Do not wait for a referee to catch you.
 - 2. Keep your goggles on.
 - 3. Put the barrel sleeve on, engage the safety on the marker, and hold your gun in the air.
 - 4. Go directly to a safety zone.
 - 5. Do not converse or participate in the game in any manner.
- **E.** NO CHEATING Anyone caught cheating, wiping off a paint hit during a game, adjusting the velocity of a marker during a game, or any other serious infraction, will be asked to leave that game and may be dismissed for the remainder of the day.
- **F.** No more than one marker per player in any game.

Any abuse or breach of the above rules and regulations shall be cause for immediate dismissal from the premises and may cause team points and standings to be invalidated.

A signed Legends Paintball Waiver Form is mandatory for every player. A waiver form is good for the calendar year in which it is signed. Players age 10-17 years old need a **parent or legal guardian** to sign their waiver form. We can not accept anyone under the age of 10 at the time of play. **No other relative or adult can sign for someone under 18 years of age**. No other notes or waiver forms will be accepted.

Legends Paintball Waiver Form

The undersigned hereby agrees to the above listed rules and regulations regarding any and all paintball games that they will be participating in/on the property of Legends Paintball; or organized by Legends Paintball, 11099 Ponderosa Timbers Dr., Conroe, TX 77385. The undersigned has expressed their knowledge of the game of paintball and the basic types of clothing, protective devices, markers, and ammunition that are common to the game and is aware of the potential risks and hazards involved in participating in such games. The undersigned agrees that they shall hold Legends Paintball harmless and indemnify the same against all charges, claims, suits, demands, and any liability whatsoever arising out of, or in conjunction with, the game of paintball or any activity related to that. Legends Paintball reserves the right to refuse access to the property to any and all persons and to cancel the right to use the property to anyone at any time. Legends Paintball may also terminate any and all games without notice and cause any and all participants to leave the property boundaries. Dismissal from the property of any violator of the rules and regulations shall not absolve the violator from any liability or prosecution, either civil or criminal, arising out of their actions.
